Note: The occupational category, called the BCAT, is not limited for inclusion in the Corps. Thus, employees with an instructional BCAT beginning with 2 (faculty), as well as temporary faculty (BCAT of '922' or '932'), administrators (BCAT beginning with "1"), or any other BCAT may be included in the *Corps of Instruction*. This means that employees who are generally considered "faculty," but who are employed as chairs, deans, or other administrators, are part of the *Corps of Instruction*.
